Emil "Ed" Thompson

Born: March 3, 1868, in Stockholm, Sweden

Died: April 27, 1899, at age 31

1st HFD Line of Duty Death

Entered HFD: January 1, 1897

Assignment: Pipe and Ladderman-
Hose Company No. 5

Buried: Glenwood Cemetery, Fireman's Plot,
Section C, Plot 98, East Half

Emil Thompson died after being hit by No. 56 Texas Central Railway Train. The crew was responding to a house fire located at 1508 Crockett Street and Johnson Street. Houston Avenue was the fastest route, but was not always the best, especially after heavy rain. The driver, Henry Donnley chose to take a different route to avoid Houston Avenue. Hose Wagon 5 was attempting to cross the railroad tracks at Hickory Street, which had an unusually steep grade and had a blind spot. The hose wagon was already crossing the tracks

when the driver realized they were in jeopardy of being hit by oncoming railcars being pushed through the crossing. The driver shouted at the well trained horses, and was able to avoid being hit by the train. The crew members riding in the back feared the fire apparatus would not clear the tracks in time and began jumping. Thompson was the last man off and fell backward into the path of the train where he died instantly. Emil was survived by his wife of five years, Winona; they were married March 22, 1894.



Frank William Medlenka

Born: June 15, 1859, in Louisville, Kentucky

Died: November 23, 1901, at age 42

Frank, the driver of horse-drawn Steamer 8, was responding to call received from Fire Alarm Box 315 at the corner of McKinney Street and Chartres Street. The steamer crossed street car tracks at the intersection of McKinney Street and Jackson Street where new tracks were under construction. Hose Wagon 8, leading the way, displaced planks covering the site causing Steamer 8 to overturn. Frank was crushed under the overturned steamer and was taken to St. Joseph's Infirmary where he died later that night. Frank Medlenka entered the

Houston Fire Department at age thirty-six. His father owned one of the first local newspapers, the "Houston Herald," which later became the "Houston Chronicle," where Frank worked as a pressman. He developed an allergy to the ink; his condition was called "The Printer's Disease." His doctor advised him, for his health, to change professions, which he did. Frank was a member of the Houston Volunteer Protection Hose Company No. 1 from 1883 to 1887 as the First Assistant Foreman. In September 1895, he became one of the first paid Houston firefighters.



Clifford William Johnson

Born: April 1, 1878, in Houston, Texas

Died: June 13, 1902, at age 24

Clifford Johnson, driver of the Fire Chief's buggy, died while responding to a fire located at 1611 Franklin Street and Crawford Street. His assignment was to pick up Fire Chief "Jack" Arto at home and respond to the fire. He was traveling at a high rate of speed on Crawford Street and as he passed Washington No. 8, he ran into the rear of a slow-moving buggy without taillights. The men at the fire house tried to warn the civilian driver but were unsuccessful. Johnson was transported to St. Joseph's Infirmary where he died early the next day.



Barnett Cohen "Barney" Moffatt

Born: October 10, 1858, in Houston, Texas

Died: April 26, 1908, at age 49

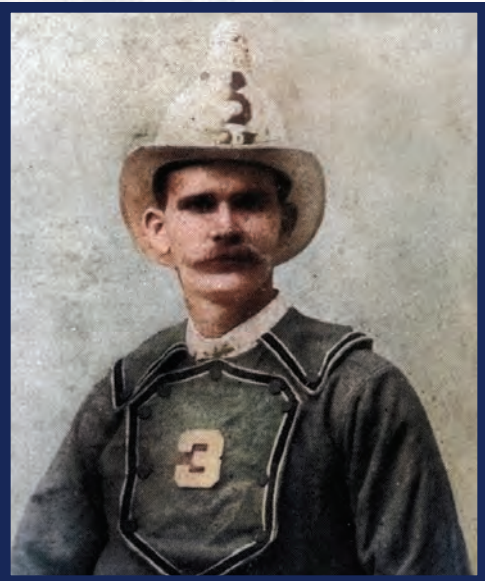

Barney Moffatt died while fighting a fire at the Mercantile Grain Company, located at 1215 Hardy Street and Lyons Avenue. He was doing clean up with his Lieutenant, Lawrence Lazzio. They were working on the ground floor of the building, assigned to check for hot spots. The floor was overloaded and stacked to the ceiling with sacks of feed, which caused the floor to weaken and collapse into the cellar. Barney fell with the floor and perished; Lawrence was able to survive by grabbing one of the pipes in the ceiling. Just prior to Barney's death he

had been off over a year after being injured in an accident while driving Hose Wagon 5. After recovering from his injuries, he was assigned to Fire House No. 7. From 1886 to 1895, Barney served with the Houston Volunteer Stonewall Hose Company No. 3. Barney was one of the first firefighters hired when the City of Houston went from a volunteer department to a paid department in September of 1895.



Thomas Andrew "Tom" O'Leary

Born: November 21, 1860, in Newport, Wales, UK

Died: December 24, 1908, at age 48

5th HFD Line of Duty Death

Assignment: Fire Chief-Central Fire Station

Buried: Glenwood Cemetery,
Section West Avenue, Lot 343, Space 1

Fire Chief Thomas O'Leary lost his life while he and his crew were trying to extinguish a fire in a railroad boxcar loaded with fireworks. The fire took place on the afternoon of November 22, 1908, in the Houston Belt Terminal Railroad switching yard located east of downtown. The fire started when a switch engine kicked a boxcar into a boxcar loaded with the fireworks. The collision of the two boxcars caused an explosion and the ensuing fire. Chief O'Leary was directing his men with little or no concern about the exploded boxcar because the explosion blew the roof off the car, thus minimizing

danger. The main concern was the possibility of the fire reaching the other rail cars; however, unknown to the firefighters, large shells for aerial fireworks were on board the boxcar. Those who investigated the accident believed that one or more of the shells exploded in the end of the car where Chief O'Leary stood. The Chief took the full brunt of the blast. Five firefighters were injured and taken to St. Joseph's Infirmary, along with Chief O'Leary. Tom fought courageously for his life until December 24, 1908, when he lost his final battle. Tom was the foreman of the Houston Volunteer Stonewall Hose Company No. 3 from 1889 to 1895. In September of 1895 he was hired as one of the first paid Houston firefighters. Chief O'Leary became a naturalized citizen in 1878 at age eighteen. He was survived by his wife, Amelia and his daughter Irene, who was fourteen at the time of her father's untimely death.



Herman Joseph "Dutch" Wagner

Born: June 2, 1871, in Chicago, Illinois

Died: May 25, 1912, at age 40

6th HFD Line of Duty Death

Buried: Washington Cemetery (Glenwood Cemetery),

On May 19, Captain Wagner was struck by a heavy timber while fighting a fire at the six-story Stowers Furniture Building located at 701 Main Street between Rusk Street and Capitol Street. The fire destroyed a whole city block, including three adjacent buildings. He was transported to St. Joseph's Infirmary, where he fought for his life for six days. After surgery was performed in a final attempt to save his life, he never regained consciousness. A local newspaper dubbed the incident "The Multi-Million Dollar Fire."

Captain Wagner had remarked to his wife one day when they were downtown that the Stowers Building was dangerous and would someday kill a firefighter. He never thought the firefighter would be himself. Herman Wagner was one of the first paid firefighters hired when the City of Houston went from a volunteer department to a paid department in September of 1895. Herman was survived by his wife Emma. They had two daughters, Lilly, age seventeen and Agnes, age seven, and a son Eddy, age fifteen.



Clifford Allen Wiese

Born: June 10, 1891, in Houston, Texas

Died: July 14, 1913, at age 22

7th HFD Line of Duty Death

Buried: Magnolia Cemetery, Section 39, Space B, in the Wiese family plot

Clifford Wiese had worked for the Houston Fire Department for a few months in 1912. He had been reinstated for ten days when he was a victim of an accident on July 14, 1913. Clifford was assigned to Fire House No. 3 located at 1919 Houston Avenue and Spring Street. His duty the day he died was that of driving a mule-drawn supply wagon and delivering supplies to the various fire houses around the city. Upon completing his daily deliveries, he began the trip back to Fire House No. 3. There was a railroad track that ran beside the fire house which was in need of repair. The maintenance crew of

the Missouri-Kansas-Texas Railroad was repairing the track with a work train that consisted of various types of cars used to hold the needed equipment and materials. Wiese and his wagon were traveling on Johnson Street and were less than five hundred feet from the back of the fire house when he began to cross the railroad tracks to turn onto Spring Street. At the same time the locomotive of the work train was pushing its railcars across Johnson Street where Wiese was attempting to cross. The lead railcar hit the wagon splintering it into many pieces, injuring the mule and fatally injuring Clifford. Clifford was taken by ambulance to St. Joseph's Infirmary where he died several hours later. Clifford was survived by his parents, Gustav and Loretta, and his four sisters, Olive, Norma, Cordelia, and Maude.



Patrick O'Hara

Born: March 17, 1878, in Dublin, Ireland

Died: September 21, 1913, at age 35

8th HFD Line of Duty Death

Entered HFD: 1906

Assignment: Lieutenant-Fire House No. 6

Buried: Calvary Cemetery, Cleveland, Ohio, Section 9, Lot 1207, Grave 2

Patrick O'Hara died responding to a signal transmitted from Fire Alarm Box 412, located in the Fourth Ward, San Felipe Street and Hobson Street, where a small shack was burning. Engine 6 hit a hole in the street where the bricks were missing. O'Hara was thrown from the side of the engine and fell against a telegraph pole where he died instantly. The accident occurred at Sabine Street and Lubbock Street at 7:30 a.m. His body was put on a train by the Westheimer Undertaking Company and sent to

Cleveland, Ohio where his two sisters and brother lived. Patrick, at age twenty three, immigrated to the United States via Ellis Island in 1901 and married his sweetheart, Sarah Haggerty on September 16, 1902. O'Hara petitioned to become a citizen of the United States in 1905 and moved to Houston, Texas to become a member of the Houston Fire Department in 1906.



Robert Rutherford Glass

Born: September 14, 1882, in Houston, Texas

Died: December 1, 1913, at age 31

9th HFD Line of Duty Death

Entered HFD: 1902

Assignment: Driver-Central Fire Station

Buried: Evergreen Cemetery, Section B2, Plot 21, Space 3

Robert was the driver of Auto Chemical Engine 1. He died while responding to a house fire in the Fifth Ward. While exiting the Central Fire Station, the apparatus collided with Car No. 119 of the Galveston-Houston Electric Railway as it was leaving the round house, which was nearby the Central Fire Station, for a round trip to Galveston. Glass was transported by ambulance to St. Joseph's Infirmary with two of his crew members, George Richardson and Raymond Cabanaugh while both of them were released and returned to work, Robert

succumbed to his injuries the next morning at 9:35 a.m. Robert was survived by his wife of seven years, Della, and son James. Robert was the Vice President of the City Fireman's Union No. 9629, organized on March 5, 1902. He held that office from 1906 to 1908. The union was disbanded after Fire Chief O'Leary died in the line of duty in 1908. The new Fire Chief, Reginald "Kid" Ollre, was never in favor of an organized union.



H. A. "Ace" Harris

Born: October 24, 1873, in Calvert, Texas

Died: February 14, 1921, at age 47

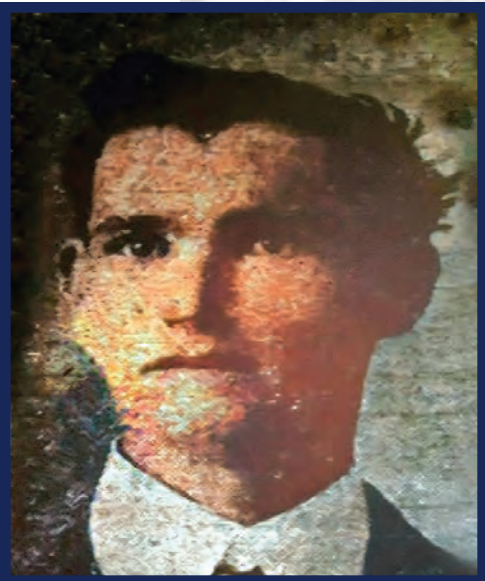

Before H. A. Harris became a member of the Houston Fire Department, he was a member of the Dallas Fire Department for twelve years. When he moved to Houston, he painted houses until he was hired by the HFD. He had been a member for three and a half months when Engine 10 responded to a fire at the Texas Lamp and Oil Company located at 203 Baker Street and Cedar Street. Due to the lack of water supply, the fire crews had to drag hose lines through a narrow alley to reach the burning building. Harris, along with the other crew members, entered the alley

with two hose lines in order to gain access to the building. Meanwhile, another crew opened a door on the opposite end of the building. This created a backdraft causing multiple barrels of denatured alcohol to explode, blowing out the wall bordering the alley, trapping Harris and seven other firefighters. Harris did not perish from the falling wall; the heavy lamp oil suffocated him. The company suffered over one hundred thousand dollars worth of damage. The cause of the fire was faulty electrical wiring. Harris's death was overlooked by the fire department for seventy-nine years. A scrapbook was obtained from the estate of a Houston firefighter, Chief Grover Cleveland Adams, contained a "Houston Press" clipping dated February 15, 1921 verifying Harris' service.



Harry Dodd

Born: November 17, 1883, in Kinney, Texas

Died: July 26, 1923, at age 39

Buried: Hempstead Cemetery, Hempstead, Texas,
located in the Dodd Family Plot

Harry Dodd died when Hook and Ladder 1 responded to a house fire located at 1315 Shaw Street and Andrews Street. The fire apparatus was involved in an accident at the intersection of Dallas Street and Milam Street. A doctor, who was rushing to take care of a patient, entered the intersection at the same time as Hook and Ladder 1. The two vehicles

hit with such force that the ladder truck was pushed into the Chapman Street Trolley that was stopped waiting for the fire truck to clear the intersection. Several of his crew members and four civilians were injured in the collision. Harry did not survive the accident.



John Andrew "Bob" Boyd

Born: November 3, 1870, in Galveston, Texas

Died: August 4, 1923, at age 52

Assignment: First Assistant Chief-Central Fire Station

Buried: Holy Cross Cemetery, Section H, Plot 71, Space 6

Chief Boyd died when Chemical Truck 1 responded to a reported house fire. The apparatus was attempting to avoid a collision with a passenger car and struck a telephone pole at the intersection of Congress Street and Hamilton Street. Chief Bob Boyd was transported to St. Joseph's Infirmary where he died several hours after arrival. Two of the three firefighters on the truck were injured, and were also taken to St. Joseph's Infirmary. Frank Haynes, the driver of the passenger car was later charged with negligent homicide.

Bob Boyd began his career as a paid driver with the Houston Volunteer Stonewall Hose Company No. 3. He held this position from 1892 to 1895. In September 1895, he became one of the first paid Houston firefighters. He left the fire service in 1919 to serve as a trainman on the Southern Pacific Railroad. In May of 1923, Fire Chief Cornelius "Roxy" Ollre became angry with the two current Assistant Chiefs, and demoted both of them. He contacted Boyd and convinced him to return to his previous position of First Assistant Chief. He died just three months after he returned to the ranks of the Houston Fire Department.



Harold Albert Denny

Born: September 6, 1905, in Houston, Texas

Died: May 1, 1924, at age 18

Buried: Washington Cemetery (Glenwood Cemetery),
Section D, Lot 44, Space 4

Harold Denny, very new to the department, died when Engine 9 collided with a streetcar while responding to a fire at the Blue Front Boarding House located at 404½ Milam Street and Preston Street. At the time of the alarm, Harold was not on duty but was bringing bed sheets to his brother-in-law, John S. Little Sr., who was the Captain at Fire House No. 9. When the fire call came in, he responded with the crew.

The driver of Engine 9 used the North Main Viaduct, and they exited the north end, a streetcar hit them, Denny died instantly, one crew member was injured. Harold's brother-in-law, Captain Little, died in the line of duty five years later on July 11th, 1929.



George LaSalle Bishop

Born: April 4, 1884, in Montgomery, Texas

Died: March 1, 1926, at age 41

Assignment: Captain-Engine Company No. 4

Buried: Forest Park Cemetery, Lawndale,
Section J, Plot 128, Space 2

On Sunday, February 28, 1926, Captain Bishop's crew responded to a two-story vacant house fire located at 2707 Grant Street and Westheimer Road. On arrival, the structure was heavily involved. Captain Bishop led his crew up the rear outside staircase. Once they reached the second floor porch, the chimney collapsed and fell into the porch. The impact ripped the porch away from the house, throwing

the men to the ground. A large number of bricks and debris fell on Captain Bishop, severely injuring him. Captain Bishop was transported to Jefferson Davis Hospital where he died at 7:20 a.m. the following morning. George was survived by his wife of eight years, Dora.



Claude William Edmonds

Born: September 25, 1894, in Scooba, Mississippi

Died: August 19, 1926, at age 31

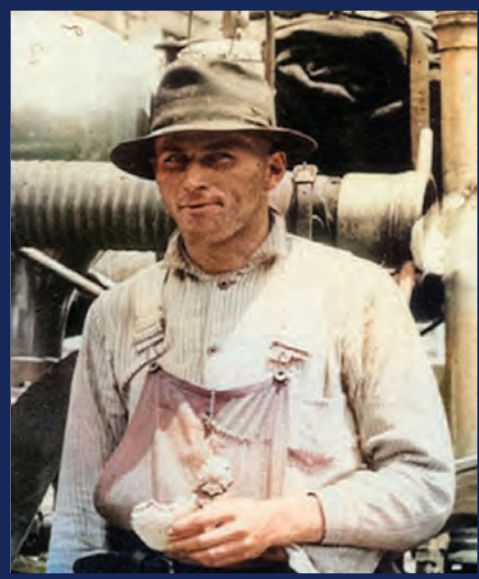

Captain Edmonds was conducting a ladder drill with Ladder 1, in the parking lot beside the Central Fire Station. The eighty-five-foot aerial ladder was raised and the firefighters were taking turns climbing down the backside of the ladder. This was not a routine fire department drill. Several firefighters had climbed the ladder before Captain Edmonds took his turn. As Captain Edmonds reached the top of the ladder, it began to sway in the wind and suddenly cracked and fell across Preston Street hitting an overhead trolley car wire where the ladder broke again. When this happened,

Captain Edmonds fell to the street where he was critically injured. Claude, was taken to St. Joseph's Infirmary where he died a short time later. Claude was survived by his wife of five years, Myrtle. Tom Powers, early into his career, was climbing the ladder just below Captain Edmonds. The ladder broke right above Tom; he was not injured. He went on to serve the citizens of Houston for fifty years.



James Magerson "Mag" Smith

Born: August 23, 1891, in Taylor, Texas

Died: February 9, 1929, at age 37

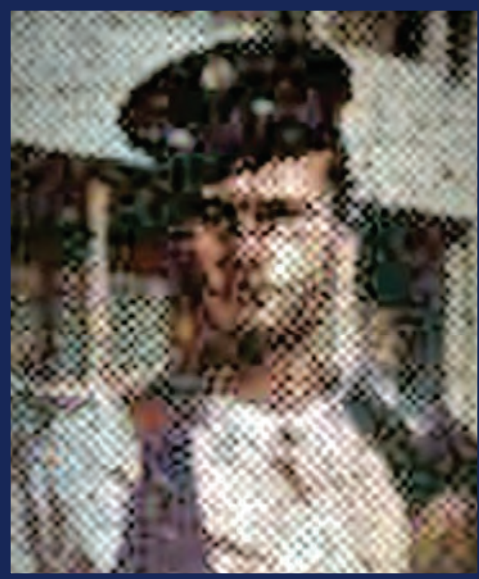

James died while hooking up a hose line to a fire hydrant during a heavily involved house fire located at 2704 Congress Avenue and Dowling Street. Engine 10 arrived at the scene, and stopped at the fire hydrant down the block. Mag got off the back of the fire truck to hook a hose line to a fire hydrant. When Engine 10 proceeded to the fire, a hose coupling caught in the bed of the pumper and pulled the end of the hose like a slingshot from the grasp of Mag. When

this happened, the hose coupling hit him in the head, the blow was fatal. Smith first entered the Houston Fire Department in 1908 at age seventeen. In 1913, after five years of service, he resigned. He was rehired in 1920 and had continuous service until his death. His brother, William, entered the Houston Fire Department in 1924 and served the citizens of Houston for forty years.



Rudolph Leon "Rudy" Hendricks

Born: September 29, 1906, in Colorado City, Texas

Died: June 22, 1929, at age 22

Buried: Rosewood Cemetery, Humble, Texas, Section I, Lot 112, Space 4

Rudy Hendricks, with less than two years in the department, died while operating a hose line at a house fire located at 3552 Reeves Street and Scott Street. A power line burned through at the house and fell, electrocuting him. He was transported to Houston Methodist Hospital but died before arrival. He was survived by his wife of two years, Mabel, his childhood sweetheart.



Edgar Henry Grant, Jr.

Born: March 20, 1902, in Houston, Texas

Died: July 2, 1929, at age 27

18th HFD Line of Duty Death

Assignment: Pipe and Ladderman-Fire House No. 18

Buried: Forest Park Cemetery, Lawndale, Section C, Plot 109, Space 7

Edgar Grant, who had been in the department almost five months, died along with Captain Little and Harry Oxford when Engine 18 was dispatched to a house fire located at 2426 Wilshire Street and Telephone Road. The incident was just before midnight; the firefighters were distracted by a large glow in the sky from the house fire. As they approached the unmarked railroad crossing at Telephone Road and Lombar-

Street, they did not see a south bound, No. 63 Gulf Coast Line Railway Train pulling fifty-four cars entering the crossing at the same time. Engine 18 was broadsided; Grant, being the most critical, was taken by private car to Memorial Baptist Hospital where he died soon after arrival. Two members of the crew were injured. Edgar was a member of the United States Navy toward the end of World War I. He was a Seaman 2nd Class and stationed in San Pedro, California. He was survived by his father, Edgar Henry Grant Sr.



Harry Lloyd "Red" Oxford

Born: July 3, 1895, in Dallas, Texas

Died: July 3, 1929, at age 34

Harry Oxford had been in the department eight months when he died along with Captain Little and Edgar Grant when Engine 18 was dispatched to a house fire located 2426 Wilshire Street and Telephone Road. The incident was just before midnight and the firefighters were distracted by a large glow in the sky from the house fire. As they approached the unmarked railroad crossing at Telephone

Road and Lombardy Street, they did not see a south bound, No. 63 Gulf Coast Line Railway Train pulling fifty-four cars entering the crossing at the same time. Engine 18 was broadsided; Harry was transported to Memorial Baptist Hospital where he died the next day at 9:10 a.m., his thirty fourth birthday. Two members of the crew were injured in the accident.



John Sellis Little, Sr.

Born: November 19, 1883, in Knoxville, Tennessee

Died: July 11, 1929, at age 45

Captain Little, with sixteen years in the department, died along with Harry Oxford and Edgar Grant when Engine 18 was dispatched to a house fire located at 2426 Wilshire Street and Telephone Road. The incident was just before midnight; the firefighters were distracted by a large glow in the sky from the house fire. As they approached the unmarked railroad crossing at Telephone Road and

Lombardy Street, they did not see a south bound, No. 63 Gulf Coast Line Railway Train pulling fifty-four cars entering the crossing at the same time. Engine 18 was broadsided; two members of the crew were injured in the accident. Captain Little was transported to Memorial Baptist Hospital. After undergoing several surgeries in an effort to save his life, John died nine days later. Prior to his assignment at Fire House No. 18, his rank was that of Battalion Chief. He, however, voted for the Mayor of Houston's rival and was punished by Fire Chief Fred Seibert. John was demoted to the rank of Captain, with that came lower pay and a new assignment, Fire House No. 18.



Michael James Ward, Jr.

Born: January 2, 1895, in Evansville, Indiana

Died: December 21, 1929, at age 34

Buried: St. Joseph Catholic Cemetery,

Michael Ward, eleven days from completing his first year in the Houston Fire Department, died with his friend Aaron O'Brien when Engine 19 was dispatched to a house fire located at Quitman Street and Clark Street. When crossing the double railroad tracks at Gregg Street, a short distance from Fire House No. 19, they were hit by a Southern Pacific Railroad Train. Buildings at the crossing obstructed the view of the oncoming train and neither the red lights nor the

swinging arm at the crossing were working. O'Brien died instantly and four crew members were injured and transported to local hospitals. Michael was visiting the fire house off-duty at the time the alarm came in and chose to ride Engine 19 to the fire when he was seriously injured and was taken to Memorial Baptist Hospital, where he died early the next morning.



Aaron Loyola O'Brien

Born: September 15, 1906 in Texarkana, Texas

Died: December 20, 1929, at age 23

Aaron O'Brien, five months into his career, died along with Michael Ward when Engine 19 was dispatched to a house fire located at Quitman Street and Clark Street. When crossing the double railroad tracks at Gregg Street, a short distance from Fire House No. 19, they were hit by a Southern Pacific Railroad Train. Buildings at the crossing obstructed the view of the oncoming train and neither the

red lights nor the swinging arms at the crossing were working. Aaron was riding on the side of the apparatus working the siren when he was thrown off and died instantly. Four members of the crew sustained relatively minor injuries. Aaron was married at the time of his death. He and his wife, Melba, were expecting their first child. Patsy Margo O'Brien was born on February 4, 1930, a month after her father died.



Charles Roland "C. R." Rusk

Born: June 3, 1880, in Akron, Ohio

Because of his failing eyesight Charles had been off work since November 21, 1931

and was due to retire. In May of 1932 he regained his eye sight and had just returned to duty on May 8th, exactly one month prior to his death. His son, Raymond, entered the Houston Fire Department eight years after his father's death, and retired in 1976 after thirty six years of service.



Esker Jackson "Jack" Rogers

Esker was off-duty the day of his accident, he was asked by a friend, to work his shift. Just as Esker relieved his friend, Engine 24 was dispatched to a call from a fire alarm box and was involved in a collision with a streetcar at Leeland Street and Jackson Street. The streetcar pulled in front of Engine 24 at the intersection. The driver turned sharply to avoid hitting the streetcar, but the fire truck slid sideways and slammed into the side of the streetcar. Esker was crushed between the streetcar and the fire truck. He was transported to the nearby St. Joseph Hospital where he died later that evening. His

Captain, Merle London and two of the firefighters, Julius "Bubba" Arto and Willie Cross were seriously injured. The passengers and operator of the streetcar were not injured. After being relieved, his friend walked to the bus stop to head home and heard the crash, which was a few blocks away. Esker Rogers was survived by his wife, Jewel, and their two sons, Johnny and Billy, who were ages six and three at the time of their father's death.

The accident was at night, the amber warning light at the esplanade was not working and this caused the driver of the

apparatus to be unable to see the obstruction. The firefighters on the apparatus were seriously injured and the driver received minor injuries. Chief Schutze was transported to the Methodist Hospital where he succumbed to his injuries. Chief Schutze was survived by Mary Leigh, his loving wife of twenty-eight years.



Walter William "Molly" Walker

Molly's assignment was at Fire House No. 2 driving the reserve engine the crew nicknamed "The Bulldog." The brand name of the engine was Mack and the Mack Truck Company used a small hood ornament shaped like a bulldog as their company symbol. The day of the accident, Tuesday, December 6, 1938 was Molly's scheduled day off. He took the place of a fellow firefighter, Hearn Hooker, who wanted the day off. Molly and "The Bulldog" were assigned to Fire House No. 17 for the day while their apparatus was at the repair shop for maintenance. While responding to a fire call,

they hit a city bus at Harrisburg Street and Sampson Street. Molly sustained a head injury which resulted in a blood clot. Back then, there was not much the doctors could do. He was sent home and died as a result of his injuries nineteen months later. Early in his career, Molly raised rabbits behind Fire House No. 3. His fellow firefighters called him, "Molly Cottontail." Over time, the nickname became "Molly." The name was so much a part of him, his wife chose to have "Molly" engraved on his headstone.

The crew was dispatched to a fire in the Weingarten's Grocery Store located at 4820 Washington Avenue and Preston Street. They were involved in a collision with Engine 2, also dispatched to the same fire. The two fire trucks entered the intersection of Smith Street

and Preston Street at the same time. Four firefighters were injured; Horace died at the scene. Horace was survived by his wife of sixteen years, Velma Agnes, and their two daughters, Gloria Nell, age thirteen and Mary Lou, age eleven, at the time of their father's death.



James Edward "Jimmy" Lowth

James Lowth was seriously injured when Engine 26 was struck by a steam powered Port Terminal Railroad Association Train after being dispatched to a fire at the Eastern States Refinery. There were two things that contributed to the cause of the accident; the warning signal at the railroad crossing was not working and the PTRR Engineer, Oliver Florrow, was seated on the opposite side of the locomotive, and was unable to see Engine 26 attempting to cross the tracks. The accident occurred at 1000 Broadway Street and Bowie Street. Four of Lowth's crew members,

Captain Mike Lathrop, J. B. Martin, Earl McWilliams, and Wilson Snow, all seriously injured, were transported to St. Joseph Hospital. Jimmy was also transported to St. Joseph Hospital where he died from his injuries. Jimmy survived World War II and returned home after serving in the United States Naval Reserves as a Radio Technician Second Class from May 29, 1942 to November 24, 1945. He died his first night back on duty since his wedding and honeymoon in Galveston, two weeks prior. He was survived by his wife of fifteen days, Peggy Leu.



John Benjamin "Red" Adams

John was survived by his wife Pearl, their daughter Vera, and three sons, Wilfred, John, and James.

The Chief's car slid on wet pavement at the intersection of Harrisburg Boulevard and Linwood Street and collided with a passenger car carrying a mother, her eighteen-month-old son and her twelve-year-old daughter, on their way to school. All three received minor cuts and bruises. Chief Dorsett died instantly, and his driver, Captain Walter Dudensing, was seriously injured. Chief Dorsett's

daughter Barbara was due to be married in Freeport that evening. Vernon was planning to get off-duty early to drive her to her wedding. Barbara and her fiancé were married two weeks later. Chief Dorsett was survived by Glennie, his wife of twenty-seven years, and their two daughters, Charlotte age nineteen, and Barbara age seventeen. Vernon Dorsett was a well respected officer and known as a "Fireman's Fireman."

Bobby Milburn, the driver of Battalion Chief 7, collided with a pickup truck at the intersection of Fannin Street and McGowen Street. Fire House No. 7 received a signal from Fire Alarm Box 3423 located at McGowen Street and Sauer Street. The truck broadsided the Chief's car with such force; it pushed it far into the side street. Although Engine 7 and Ladder 7 were following the Chief's car through the intersection, they did not see the accident. Chief H. H. "Bubba" Finn and the driver of the pickup were seriously

injured. Bobby Milburn was transported to Jefferson Davis Hospital where he was pronounced deceased on arrival. The crew of Fire House No. 7 was in the process of petitioning the city to have Fire Alarm Box 3423 removed due the high number of false alarms it received. Bobby was survived by his loving wife, Willa. They were married January 19, 1935. Also survived by his son, Ronald Gene, who was eight at the time of his father's untimely passing.

He was transported to Jefferson Davis Hospital where he was pronounced deceased on arrival. The fire involved the

Alaskan Fur Factory located at 600 Main Street and Texas Avenue and two other businesses, the National Shirt Shop and Shaw's Jewelry Store. All three businesses were heavily damaged. This fire was especially difficult due to the freezing, icy weather which kept the smoke close to the ground. The fire also played a part in the death of Captain Rufus Templet.

The fire involved the Alaskan Fur Factory located at 600 Main Street and Texas Avenue and two other businesses, the National Shirt Shop and Shaw's Jewelry Store. All three businesses were

heavily damaged. This fire was especially difficult due to the freezing, icy weather which kept the smoke close to the ground. The fire was also responsible for the death of Joseph Connor. Rufus Templet was known as a dedicated firefighter and often responded to alarms off-duty. His wife, Lottie, was responsible for starting what became the Ladies Auxiliary Club.

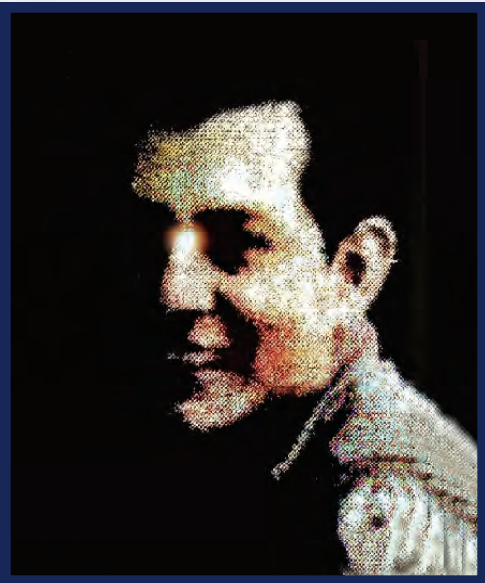

Engine 10, the first due company, was on another assignment and was replaced by Engine 8. Ladder 1 had trouble starting and was delayed leaving quarters. This put both trucks in the intersection at the same time. Seven firefighters were injured in the accident. Fidel was transported to Jefferson Davis Hospital where efforts to save him failed. This is the same

intersection where Frank Cantino died five months later on January 7, 1954. The same building on the corner, the Southern Electric Supply Company at 1605 Preston Street was damaged in both accidents. The "Houston Chronicle" dubbed it the "Death Corner." Fidel was drafted into the United States Army, September 29, 1941. He served with 35th Anti-Aircraft Artillery Brigade until his discharge December 5, 1945. Fidel had recently returned from a three-month leave of absence where he and Lucette, his war-time bride visited her native France.



Joseph James "Joe" Solito

Engine 10, the first due company was on another assignment and was replaced by Engine 8. Ladder 1 had trouble starting and was delayed leaving quarters. This put both trucks in the intersection at the same time. Seven firefighters were injured in the accident. Joe was transported to St. Joseph Hospital where efforts to save him failed. This is the same intersection

where Frank Catino died five months later on January 7, 1954. The same building on the corner, the Southern Electric Supply Company at 1605 Preston Street was damaged in both accidents. The "Houston Chronicle" dubbed it the "Death Corner." Joe was drafted into the United States Army December 2, 1942 at age twenty-eight, he served with 65th Infantry Division and was discharged January 14, 1946. 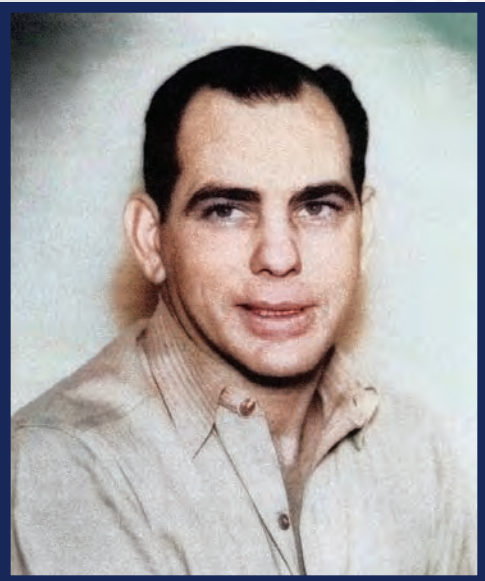

Frank, a forty-two year veteran, died while responding to an alarm transmitted by the fire alarm box at Gable Street and MKT Railroad. Ladder 1 collided with a passenger car at Preston Street and Crawford Street. The car was occupied by two nineteen-year old men who were being chased by the police; both of whom died at the scene. Four members of the crew were sent to

Jefferson Davis Hospital and were treated and released. Frank succumbed to his injuries prior to arrival at St. Joseph's Hospital. On July 29, 1953, Frank was injured at the same intersection, while responding to an alarm from the same fire alarm box, Gable Street and MKT Railroad. This is where Joseph Solito and Fidel Chabolla died. The same building on the corner, the Southern Electric Supply Company at 1605 Preston Street was damaged in both accidents. The "Houston Chronicle" dubbed it the "Death Corner."



Woodrow Wilson Erwin

Immediately after the fire was extinguished, he complained of a sharp pain in his chest and asked to be taken to the hospital. On the way to Jefferson Davis Hospital, he asked the attendants to call his wife and have her meet him

at the hospital. He died just minutes before his wife's arrival. On April 23, 1942, Woodrow, at age 18, was drafted into the United States Naval Reserves, during World War II. He received his discharge September 12, 1945 and returned to the ranks of the Houston Fire Department. He was survived by his wife, Mabel, and their daughter Joan.



Delbert Harvey Sherfy

He was survived by his wife of seventeen years, Lenna. They had two children, Daniel Harvey and Sarah Ann, who were ages sixteen and thirteen at the time of their father's death.

Delbert's Grandfather, Henry Donnelly, served the Houston Fire Department for fifty years from 1895 to 1945, retiring at the age of seventy-eight. Before Henry joined the ranks of the Houston Fire Department, he was a paid driver for the Houston Volunteer Hose Company No. 9. Delbert's uncle, Eddie, served the department from 1923 to 1945.

Bill was transported to Jefferson Davis Hospital where he did not survive his injuries. He had five

minutes left on his shift when the alarm was dispatched. Bill was drafted into the United States Army Air Forces on October 31, 1942 and served his country during World War II until being discharged from the military January 19, 1946. Bill was survived by his wife of fifteen years, Elsie Elisabeth.

truck, carrying steel beams, saw Engine 30, but was unable to stop due to its heavy load. The fire apparatus was broadsided, breaking it into several pieces. McWhorter died at the scene. He was survived by his wife of ten years, Betty Jean, they had a daughter and a son.



D. H. "Jim" Chandler, Jr.

D. H. and his crew responded to the Hess Terminal located at Federal Road for a fire on board the "Amoco Virginia." The 150,000-gallon tanker was in the process of loading a cargo of aviation fuel. A worker loading the ship did not realize there was a small hole in the hose leaking fuel into the water below. A lantern on a passing tugboat ignited the fuel, causing an explosion and fire that took sixteen hours and five hundred firefighters to control. Seven men on the ship perished and forty workers, including several firefighters,

were injured. During the cleanup process, the mangled deck was coated with firefighting foam, Chandler fell through a large gaping hole in the deck and drowned in the contents of the ship's hold. He was a diver in the United States Navy but did not survive due to the lack of buoyancy of the fuel. D.H. enlisted in the United States Naval Reserve August 16, 1951 and was discharged August 15, 1959.

The accident occurred at the intersection of Fulton Street and Berry Street as an approaching transport truck loaded with steel beams saw Engine 30, but was unable to stop due to its heavy load. The fire apparatus was broadsided, breaking it into several pieces. Due to the severity of his injuries, Jed was transferred to Brooks Army Medical Center at Fort Sam Houston, San Antonio, Texas on a plane owned by a local oil

company. Eleven days later he succumbed to his injuries. In 1940, at the of age eighteen Jed became a member of the United States Naval Reserves and served during World War II. His group protected cargo ships to keep them from being sunk by German submarines. In 1943, at the age of twenty-one, he returned to the United States and was discharged and returned home. He was survived by his wife of twelve-years, Helen, and their two daughters, Vicki and Malissa Ann, who were eight years and four months old respectfully at the time of their father's untimely death.



Dominic Joseph "Dom" Contorno

They were in

disbelief how the heart attack did not kill him instantly. Dom had a family at home and a very strong will to live that kept him alive for nineteen days. Dom was survived by his wife of twenty-five years, Jane. They had one son, Donald Gene, who was twenty-one years old at the time of his father's death.



Claude Jackson Hopkins

The apparatus hit a transport truck carrying grain at the intersection of Preston Street and Louisiana Street. Four firefighters were transported to Jefferson Davis Hospital. Claude, severely injured, died the next day. The alarm was false, caused when a vagrant attempted to get a drink from a drain valve of the sprinkler system. Claude graduated

from Jefferson Davis High School in Houston, Texas in 1950. Soon after high school, Claude joined the United States Navy on March 19, 1951. Truxton was survived by his wife of ten years, Marjorie Ann, and two children, Chris and Phillip, ages eight and six years old. Marjorie's dad, Richard Henning also served with the Houston Fire Department. Truxton graduated from Aldine High School in 1959.

eight feet from the back door. Lewis was rescued and transported to Memorial Hermann Hospital where efforts to save him failed. Upon entering the unit, they encountered moderate heat and heavy smoke and the fire had broken one of the windows. The initial search did not locate the resident, who was later found deceased. Two of the firefighters were running low on air and were sent to the stairwell. Captain Jahnke then decided

that he and Senior Captain Robert Green from Ladder 28 should do the same. Upon exiting, the hose line did not clear the apartment's self closing door, and the door did not completely shut. Simultaneously, a cold front came through, causing high winds, pushing the smoke and fire out into the hall where the two captains were attempting to escape. Captain Jahnke became disoriented and followed the hose line in the direction of the fire. He transmitted a "Mayday" and was found a few minutes later. He was carried down and transported to Memorial Hermann Hospital where he succumbed to his injuries shortly after. Jay was a highly respected officer, who was part of the Houston Medical Strike Team, Swift Water Rescue, and HAZMAT certified. He also served as the Chief Safety Officer with Cy-Creek Volunteer Fire Department.

However, upon arrival they discovered a fire in the El Festival Ballroom, an after-hours night club. Civilians at the location reported that they were not sure everyone got out of the building safely. While searching for victims the fire intensified and the crew members found their hose

and followed it to safety. While exiting the building, they realized that Kevin did not get out with them. By that time the fire had burned through the ceiling and roof. Kevin was unable to find his way out of the building. During the investigation, it was determined that the arsonist had thrown several full one-gallon plastic gasoline containers on to the roof. The fire, set because of a domestic dispute, was ruled arson. Three men and one woman were charged and convicted of the murder of Firefighter Kevin Kulow. The ring leader, Jeremy Robinson, a career criminal, was sentenced to life in prison without the possibility of parole. The other three received sentences ranging from three to forty years in prison.

Afterwards he entered the Houston Fire Academy and graduated in 1978 and this is where his career started with the Houston Fire Department. Dwight was one of the

On the morning of March 31, members of Class 2015G were going through the obstacle course at the "Survival House" at the Val Jahnke Training Facility. Steven had almost completed his turn when he collapsed. His classmates quickly brought him outside and began CPR while attempting to lower his body temperature. Medic 44 was on the grounds involved in a drill. They transported him to Memorial Hermann Hospital. Several hours later efforts to save him failed. His cause of death was ruled dehydration and hyperthermia. Steven was a well-respected cadet, mentor and

motivator to many of his classmates and had only two and a half months left of his training. He was thirty-two and older than most of his fellow cadets. His class graduated June 16, 2016 and dedicated the ceremony to him. Class 2015G placed a memorial plaque at the Val Jahnke Training Facility in his honor. In 2014 he became a member of the Texas National Guard. After completing Infantry and Airborne School, he was in line to attend Army Ranger School. The Army offered him an opportunity to attend the testing process to join the Green Berets, but he declined the offer.

Bill Dowling was a man of courage and service to others. He graduated in 1993 from Klein Oak High School. Soon after, he joined the United States Marine Corps, only after convincing his recruiter that he would succeed as a member. When he fulfilled his commitment to the Corps, he continued his quest to serve others as a member of the Houston Fire Department. On May 31, 2013 Captain Dowling was seriously injured while leading his crew during the Southwest Inn Fire. The fire started in the Bhojan Indian Restaurant, which was in the front of the motel complex.

During the fire, the roof collapsed, trapping him and four crew members. Captain Dowling was the only firefighter rescued from the collapsed building. He was transported to Memorial Hermann Hospital where he was treated for his injuries and fought to stay alive. During his fight for his life, he was given the nickname, “Iron Bill,” for his relentless efforts to heal and return home to his family. “Iron Bill” succumbed to his injuries almost four years later. Bill was survived by his soulmate Jacki, and his three children, Forrest, Faith and Foster.

After the Chief left and not hearing from Kenny in a while, he would be found by Captain Flores unconscious and unresponsive

behind Fire House No. 27. It would later be discovered that he had suffered a massive heart attack, which claimed his life. Kenny's strength, tall stature and tough shell could have made you feel intimidated, but to all those who truly knew him, he will always be remembered as a kind, gentle giant with a good soul. He had been battling the virus in the ICU at the CHI St. Luke's Health Hospital in the Woodlands. He is the second Houston Firefighter to die from COVID-19. Jerry was a fire fighter/paramedic assigned to Houston Fire Department Station 101 in Kingwood. Jerry is survived by his sons Justin and Jesse. Jerry's family moved to Houston when he was nine years old. After high school, Jerry served proudly in the U.S. Navy, attaining the rank of Petty Officer First Class. He was deployed to Operation Desert Storm in

the Gulf War in 1991. After his military service, Jerry worked for the Coca-Cola Company as a truck driver until he entered HFD in January 2004. As the oldest member of Class 26 at the HFD Val Jahnke Training Facility, Jerry shared many stories of his life experiences with younger classmates, making him a popular mentor. Often the life of the party, Jerry enjoyed cruising, basketball with friends and family, and making people laugh. Most of his career was committed to northside fire stations, where he was a popular, well-respected member of his crews. After graduating from high school, he joined the United States Navy. He went up the ranks to Petty Officer, First Class. During his time in the Navy, he was deployed to Operation Desert Storm in the Gulf War in 1991. Jerry was survived by two sons, Justin, who is a member of the Houston Fire Department, and Jesse.

Captain Tommy Searcy, an eighteen-year veteran of the Houston Fire Department, lost his life to the COVID-19 Virus. He is the third Houston Firefighter and the eighty-fourth in the United States to pass away from the COVID-19 Virus as a line of duty death in 2020. Tommy and his family received an amazing amount of support from around the world, including help from the HPFFA Local 341 and Texas Lt. Governor Dan Patrick. They were instrumental in getting access to an experimental drug that helped Tommy's body fight the virus while he was in The Woodlands Memorial

Hermann Hospital's ICU. He proudly served the community for over twenty-five years with several fire departments in the Houston area including Bellaire, Lufkin, Magnolia, and Westfield, where he became Assistant Chief. Tommy received multiple awards and commendations of valor from both the Westfield Fire Department and the Houston Fire Department. In 2019 his direct actions at a house fire helped save the life of a fellow Houston Firefighter. Captain Searcy was universally respected for his honor, pride, and tradition in the fire service. Tommy was immensely proud of, and survived by, his three daughters Kaylin, Krista, and Kinley. He is also survived by his parents Harold and Sin Chae Searcy, older brother Terry Searcy, and twin brother, HFD District Chief Tony Searcy. Forever Brave, Never Give Up, as in the words of Captain Tommy Searcy... "Come On, Let's Do This"

The suspect died at the scene. About an hour later, DJ, shot three times, died from his injuries at Memorial Hermann Hospital. DJ is the Houston Fire Department's first Arson Investigator to die in the line of duty. DJ grew up in north Houston; he was a dedicated Boy Scout and graduated from Klein Oak High

School in 1995. After high school DJ enlisted in the United States Marine Corps, where he served honorably for five years. He was one of the youngest Black Hawk helicopter crew chiefs in the history of the Marine Corps. He later served in the Army National Guard. He was survived by Rachel, his wife of fifteen years, and his two young children, Sydney and Grayson. Many of his friends have said "Life is Better with Bruce."

Tanner was the eighth in the United States and Canada, according to the IAFF, to succumb to the COVID-19 Virus in 2021. The total firefighter deaths to date is one hundred fifty-five Covid 19 related deaths as recognized by the National Firefighter Foundation. Tanner was proud to call himself a Houston firefighter and was one

the best Engine / Operators in his area. His skill and dedication to being the best at his job earned him the respect of all who worked with him; and his actions on the fire ground helped save many lives and property over the years. Tanner passed on his knowledge, respect for the job, and the right way to do it both on the fire ground and at the fire house. He was a mentor to many and his teachings made those around him better every day. He served at Fire House No. 73 and Fire House No. 77, with his last assignment as an Engineer/Operator at Fire House No. 10.

He attended several university and academy programs in pursuit of his goal to become a paramedic. He eventually archived this goal, joining the ranks of Houston Fire Department in 2005. Jordan's

training and love of everything political led to a coveted spot on the medical detail for the late former President George W. Bush. Jordan was diagnosed with cancer on October 22, 2020. Although there was no cure, he bravely fought the disease, signing up for a clinical trial in hopes he could help ease the struggle for other firefighters fighting cancer now or in the future. career as a firefighter. From an early age, Marcelo excelled in athletics. He played football for the Magnolia Park Sharks and baseball at TSU, finding in sports the values of teamwork, discipline, and service. Over the years, he mentored younger athletes, volunteering with Angels in the Outfield, Our Lady of Guadalupe Catholic School, Milby High School's baseball team, and the Magnolia Park Sharks. Marcelo answered the call to serve in 2015.
